## 1. Press conference, enquiries and direct quotes

**We would ask you to refrain from enquiries about content before the press conference.** The President of the District Court and the press officer will explain the content of the decision at the press conference. No assessment of the decision reached or the proceedings can be conducted during the press conference.

After the press conference the press officers of the District Court will be available to you for a background discussion. At the same time we hope that you will appreciate that no direct quotes will be given today outside the press conference.

## 2. Live stream and recording of the press conference

It is planned to live stream the press conference on the Internet for media representatives. Because of the restricted server capacity we would ask you in your own interest not to communicate the supplied link to others or to make it public, as otherwise you will jeopardise your own access to the live stream. At the end of the press conference a recording will be available for downloading from the District Court's Website.

The use of recordings published by the Court is permitted to journalists and media organisations free of charge for their own radio and Internet content for publication purposes for 14 days from today. For any use above and beyond this a use agreement must be entered into. For this please contact the press office of the District Court.

### **3. Attendance at the press conference**

Media representatives may attend the press conference without prior notice on presentation of a valid press pass (if this is not available, employer's confirmation from a media organisation together with photo identification will be required). Admittance to the courtroom will be at 12 p.m. Seating will be in order of appearance.

### **4. Setting up equipment**

Those wanting to set up equipment for film, sound and photographic recordings (cameras, microphones, etc.) should contact the press office as soon as possible.

Equipment vehicles can be parked in the gravel parking area at the back of the Court building (access from Landgerichtsstraße). There are no available parking spaces in front of the building. Parking there is restricted to holders of a special-use pass from the City of Duisburg.
